Prof. Soniya Sirsat, Director, IQAC gave a quick review the current status of the Institution, the strengths and weaknesses and the challenges the institution is facing.


A thorough discussion was held on key goals for the IDP, long-term vision of the institution, immediate needs and priorities, measurable outcomes and key performance indicators.




















3. **A.O.B.** : Since there was no matter to discuss the meeting ended with closing remarks by the Principal at 12.10 p.m.




